MESSAGE FROM GREEN COUNCIL CHIEF EXECUTIVE OFFICER



Dear friends and distinguished guests,

This year marks the 23rd anniversary of the Green Council (GC)! Over the past 23 years, GC has grown and evolved into a beacon of excellence and innovation. We have overcome challenges, embraced change, and achieved remarkable milestones together. This anniversary not only marks a significant milestone in our "from green to sustainability" journey, but also symbolises the commitment of our network members and stakeholders.

In partnership with the Water Supplies Department (WSD) of the HKSAR Government, GC successfully organised the Enterprises Cherish Water Campaign (ECH2O) and held the ECH2O Awards Ceremony to commend the contribution made by the participating organisations and staff to water conservation. The ECH2O has garnered the participation of 624 commercial and industrial organisations. All participating premises have achieved a significant reduction in overall water consumption in 2022 by 5 per cent, or about 500 000 cubic metres, which is equivalent to 200 Olympic-size swimming pools. I would like to express heartfelt gratitude to all the organisations for their active participation in the ECH2O and remarkable achievements in reducing water consumption.



Waste is one of the top three sources of carbon emissions in Hong Kong. The Municipal Solid Waste (MSW) charging will be implemented on 1st April 2024. GC is excited and proud to support the Government's waste reduction strategy as always. GC is commissioned by the Environmental Protection Department (EPD) as a training contractor to provide cleansing services companies with the essential knowledge of the statutory requirements and implementation details of MSW charging. Entering its second year of operation, the EPD's Recycling Store - GREEN@Happy Valley, managed by GC, continues to provide convenient recycling support to the community, collecting an average of 25 tonnes of recyclables per month.



Internationally, we continue to make our engagement known and appreciated. GC has successfully become an admitted NGO of the United Nations Framework Convention on Climate Change, which enables us to attend Conference of the Parties (COP) meetings as an observer organisation. Not only will we be able to bring the latest information back to our network and stakeholders, but we will also be able to pursue and forge new alliances with other like-minded entities operating around the world.

I am happy to announce that this year the Hong Kong Green Awards has a record number of applications! Most of the questions were upgraded to incorporate elements of Environmental, Social and Governance (ESG) and carbon reduction into the award criteria. GC will continue to broaden and strengthen our Awards to reflect the latest changes in regulations, policies and trends.







































The third United Nations Sustainable Development Goals Achievement Awards Hong Kong was organised to identify and recognise organisations with exceptional performance on their business practices and sustainability projects that meet the Sustainable Development Goals (SDGs). As an "Accredited NGO" officially recognised by the United Nations Environment Programme (UNEP), it is GC's intention and duty to help promote, pursue and advance the 17 SDGs.

With the efforts and positive momentum achieved this year, I am confident that I will be able to further enhance and complement our work programme. While current initiatives will expand and evolve, more unique and complementary initiatives will be introduced to guide and assist our network members as well as other stakeholders in their sustainability transformations.





Enterprises Cherish Water Campaign (ECH20) Awards Ceremony

Currently, non-domestic water consumption accounts for about 45% of fresh water consumption in Hong Kong. In view of this, the Green Council and the Water Supplies Department of HKSAR Government jointly organised the "Enterprises Cherish Water Campaign (ECH20)" in 2021 to create a collaborative platform for the commercial and industrial sectors to promote water conservation through various activities.

The ECH20 has garnered the participation of 624 commercial and industrial organisations. All participating premises have achieved a significant reduction in overall water consumption in 2022 by 5%, or about 500,000 cubic metres, which is equivalent to 200 Olympic-size swimming pools. Some premises also worked with their suppliers to produce a tailor-made flow controller for their faucets. Many organisations adopted different innovative measures to cherish water including water leakage detection devices, soil moisture sensing automatic sprinkler system, etc.

On 22 March 2023, which is also the annual World Water Day, the first Awards Ceremony of ECH2O was held to commend the contribution made by the participating organisations and staff to water conservation. A total of 180 premises was recognised.


